RE: 2015 Campus Safety and Security Survey

Attached to this document you will find our 2016 campus crime report as reported to the U.S. Department of Education for the twelve month period beginning October 1, 2014 – September 30, 2015. The information contained in the report is compiled in accordance with the provisions of the Jeanne Clery Disclosure of Campus Security Policy and Campus Crime Statistics Act and the Violence Against Women Act of 1994 (VAWA). As required by law, this statement and the Campus Safety and Security Survey shall be distributed to all students by October 1, 2016. These documents will also be published to the college website.

This report includes statistics for the previous two years concerning reported crimes that occurred on campus; in certain off-campus buildings or property owned or controlled by Trenholm State Community College; and on public property within, or immediately adjacent to and accessible from either campus. The report is compiled from local college sources and data from the City of Montgomery Police Department for 2015.

Trenholm State Community College properties continues to maintain a good safety posture. As indicated in the attached report, there were three reportable events committed on or near our campuses. As with previous years, we continue to report theft of college property that meets the reportable guidelines of the Clery Act. By law, and according to the Clery Act Handbook, events are reported regardless of legal interpretations, therefore this report is compiled according to the following statement:

“You must **disclose reported offenses**, not the findings of a court, coroner or jury or the decision of a prosecutor. Classify and count crimes from the records of calls for service, complaints and investigations.”

The college has continued to enhance the presence of security guards on the Patterson and Trenholm campuses by extending security services to 24 hours per day and 18 hours per day at the library. On the Trenholm campus a surveillance camera expansion project was completed to significantly expand the system. As a result, a number of events have been captured on video and used as evidence that would have previously not been possible. A lighting project to improve lighting on the Trenholm campus has been completed and a new project is underway for the library. The Patterson campus is undergoing extensive renovation that will have improved lighting and expanded surveillance systems. The renovation on the Patterson campus also includes infrastructure changes to add campus emergency call stations in the near future. Further, to protect college resources, HVAC units on our most venerable buildings have been caged to make it more difficult to damage the units and have proven to be an effective theft prevention measure.

The College is required to provide a system to notify you of emergency and non-emergency events. The responsibility to initiate those notifications rest with the office of Information Technology and Campus Safety. One or all three systems may be used to provide these notifications in time to be useful. Those systems are hereby known as, Trenholm Alert, Alertus, and the Alert Notification System. Depending on the event, some systems will not be used as an added measure of safety. The systems will never be used for general messages, however will be used for practice drills.

Trenholm Alert - Subscriber based system that provides SMS text messages to your mobile phone, text to speech messages to phone numbers you choose to be contacted, and email. More information about this system can be found at <http://www.trenholmstate.edu/college-info/tstc-trenholm-alert.cms>. The system is also integrated with the college Twitter account and Alertus below.

Alertus - An electronic system, tightly integrated into Trenholm Alert. Not specifically for students, however messages received by employees will affect your behavior and actions in an emergency.

Alert Notification System - Radio based loud speaker system containing canned messages. Can be considered a giant voice or intercom type system reaching the entire college. Will be used to notify you of severe weather and building evacuations.

Providing a safe environment for learning is the responsibility of every employee. It is through your continued vigilance and zero tolerance for disruptions to college business that enables the college maintain its strong safety posture.
